C. Bequests

Judith F. Dolkart presented a restricted gift of 44 lots (individual items, sets or pairs), French Faience from the Bequest of Sidney R. Knafel. 30 of the lots are being presented to the for approval for accessioning, and the remaining 14 lots of non-accessioned art will be sold at public auction in accordance with the estate trust documents of Sidney R. Knafel, with the funds from auction to be used to support the DIA's Sidney R. Knafel French Faience Collection Fund. Per Alan Darr in his report:

These fourteen pieces equate in value to \$160,500—less than 20% of the overall appraised value of \$889,500 (or 20% = \$177, 500 in value) which the estate allows the DIA to sell at public auction for the future care and display of the DIA Knafel Faience collection and possibly one or more additional faience acquisitions in the future. Thus, the fourteen pieces donated and listed as non-accessioned gifts are those which the DIA will sell at auction in 2023 or later. The estate also requires that at least 10% of the gift be on public display, i.e. three or four pieces to be displayed, or more as preferred, in the European galleries.

Motion made, seconded, and carried to approve the restricted gift.

FINANCE & INVESTMENT REPORT

Kate Spratt, CFO, delivered a financial update.

2022 FY Audit Results

- Plante Moran has issued an unmodified opinion (highest level of assurance) on the financial statements, stating that:
 - The statements present fairly the financial position of the DIA
 - The DIA's analysis for accounting entries is appropriate
 - Reasonable judgments and consistency have been applied
 - Financial Statement disclosures are neutral, consistent, and clear
 - Strong cooperation and communication between the DIA and PM
- Audit finding reported related to internal controls with user permissions for payroll and accounting systems; Corrective action implemented to address issue.
- The audited financial statements will be posted to the DIA's website and copies are available from the accounting department upon request

FY 2023 Financial Summary

The DIA's financial performance has been consistent with budget for the first three months of the 2023 Fiscal Year

- Revenue is \$300,000 unfavorable to budget for the Quarter
- Expenses are \$300,000 favorable to budget
- Unrestricted operating results are consistent with budget
- Spending from restricted funds is within budget for capital projects, art acquisitions and auxiliary & volunteer groups. Exhibitions costs are higher than planned through September, which will be reduced as Van Gogh revenues are generated.
